A PLACE TO BELONG

A family new to the United States discovers community through swim lessons

Mohamad, his wife Kawthar, and their four children, are originally from Syria but left to live in Jordan when the war started. After 10 years there, they came to the United States for safety and opportunity for their family. The move has brought a lot of change for the Alwan family, but it has also brought them a new sense of community at the YMCA.

Through a scholarship, Mohamad and Kawthar's older children have learned to swim and play soccer. Their youngest daughter Ayla, age 2, is already experiencing the water and enjoying pool time with her dad.

Mohamad says the Y feels like a family. "The people here are beautiful. Sometimes I'm at work, so my wife brings the children. This is a safe space, I don't worry about them. The Y is like a family," Mohamad says. "Like my family."

Young people are finding – and building – belonging at the YMCA Teen Center

Isaiah is building confidence—staying active and forming new friendships that keep him coming back. Armani is discovering her love of music, building creative skills that support her dream of becoming a sports photographer. And after moving to Erie, Zakhi found more than a new city—he found a place where he feels safe, welcomed and connected.

Their experiences are different, but through the YMCA Teen Center they share something powerful: a space where they can be themselves and grow into their full potential.

Through five key focus areas—Creative Arts and Expression, Health and Wellbeing, Recreation and Social Groups, Educational Support, and Personal and Professional Development—the Teen Center supports the whole person and opens doors to new opportunities.

In this video, teens share what this community means to them—in their own words. They talk about their interests, the challenges they've faced and the importance of having trusted people to turn to. Just as importantly, they reflect on how they help create that same sense of community for others who walk through the doors. Because at the Y, a sense of belonging isn't just something you find—it's something you help build.

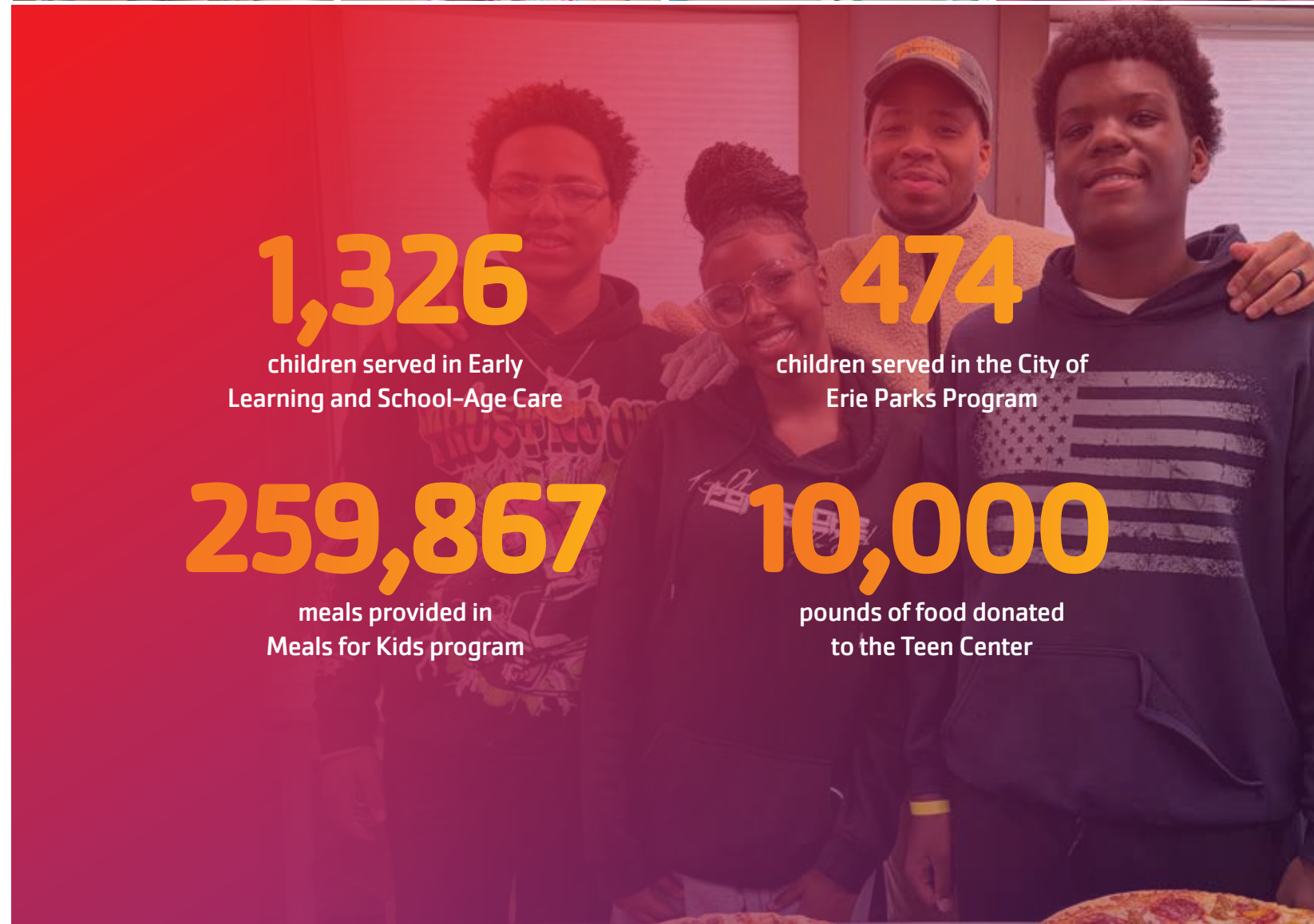

A special volunteer brings joy and connection to YMCA members

Jake greets members with a smile that's easy to recognize, even before any other communication is exchanged. As a YMCA volunteer, Jake has become a joyful and welcoming presence—someone people look for when they walk through the doors.

But conversations with Jake happen a little differently—often through gestures, shared effort and growing sign language skills. Jake is deaf, but his connections with staff and members go far beyond words. Over time, those interactions have inspired others to learn, to slow down and to connect in new ways. What starts as a simple exchange often turns into something more meaningful—a moment of understanding, a shared laugh, a relationship built by patience and affection.

Among those connections is a special friendship with a single dad that has brought consistency, companionship and meaning to them both. It's a reflection of how relationships take shape at the Y—organically, authentically and – often – at just the right time.

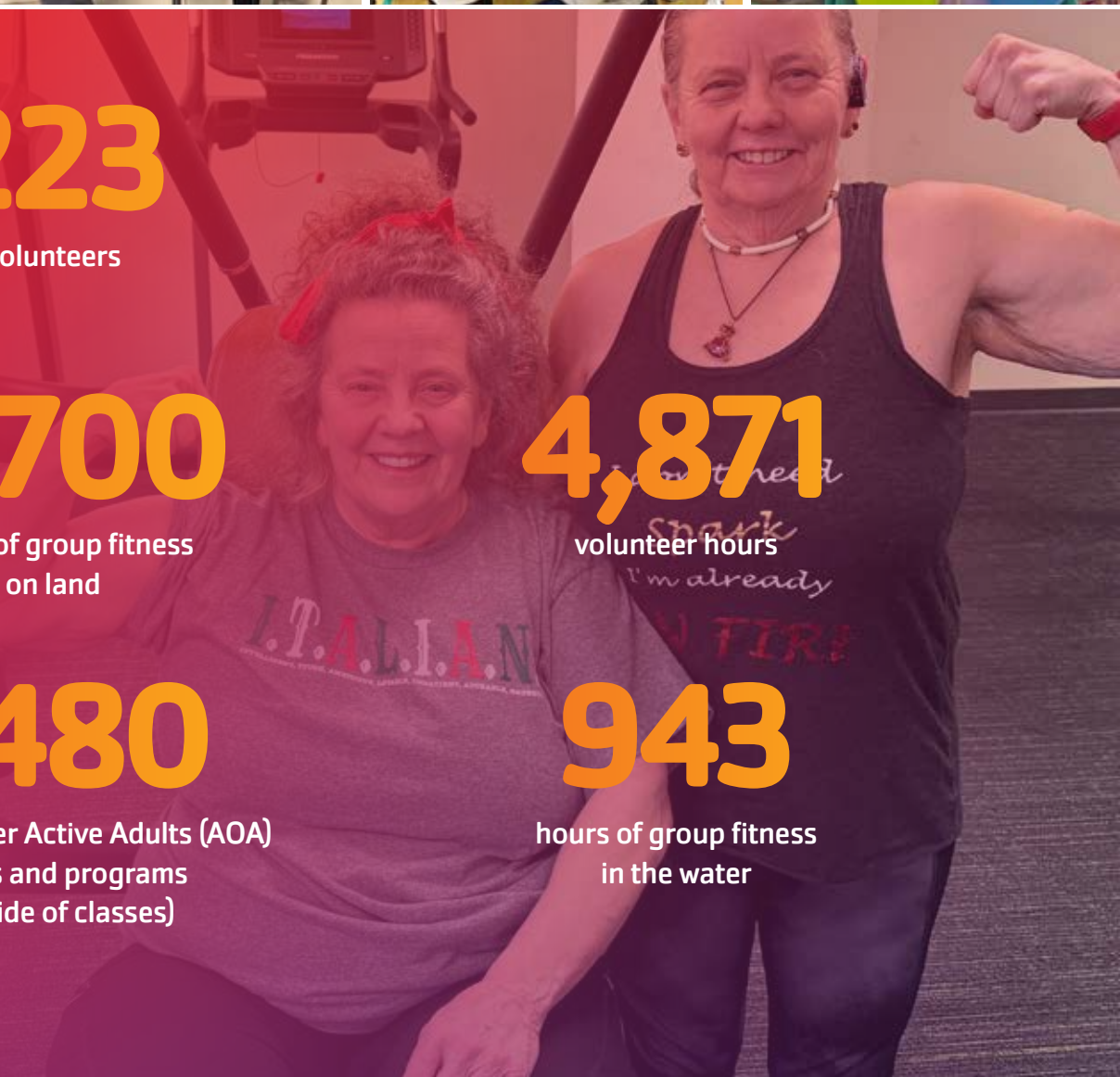
